WFDSS O&M Update/Status

- We are working to update the directions for non-fed users IT security training. We should have more information next month.
- o The next WFDSS O&M release is scheduled for July 29th- it will address 50+ high and medium priority bugs/issues
- We post the patching schedule and planned reboots to the WFDSS GAE
 Training Calendar
 - A planned reboot to correct a websphere vulnerability will occur on Friday, June 26th from 2200-2300 Mountain Time.
 - July patching: July 7th Production from 03:00 to 04:00 and Training from 22:00 to 23:00 Mountain Time. July 10th WIMS reboots (i.e. no fire behavior modeling) from 00:30 to 01:30 Mountain Time.

IRWIN Updates

 WFDSS has remained connected with IRWIN version 6 since March 9th, connection is stable.

Geospatial Data

• We are considering increasing the point and vertex limits on unit shapes from 100 to 500 for points and from 75,000 to 250,000 for polygons. This change has been made on Training only in order to test the viability. We are looking for units that would like to test this change on Training and provide feedback regarding map loading speeds or other degraded performance. Units can go ahead and test it at their own convenience now (on Training only). We ask that feedback/issues/success be sent to Andrew

Bailey and Rick Mowery. If we can be assured this does not impact performance we will work toward making these changes to Production.
