Common Issues and Resolution

• The Known Issues Document was updated after our January 27th release.

• WFDSS O&M Update/Status

• Our most recent release (6.4.8) occurred Jan 27th. See <u>Release Notes</u> for specifics on what was addressed.

 Highlights: addressed the striped/corrupted LCP issue that was impacting analysts, Improved multiple items relating to shapes, such as improved error messages to user when shapes fail, IRWIN V7 prep work and lesser IRWIN issues.

• Our March release has been postponed and will now occur April 28th in concert with the IRWIN V7 Release. Release items include IRWIN V7 code, bug fixes, and maintenance work.

• LANDFIRE 2016 is being reviewed in our Dev environment- we are slowly but surely getting it processed and hope to have it in Training and Production soon.

• IRWIN Updates

 IRWIN V7 testing occurred last week. The following V7 changes will be addressed in the next WFDSS release in concert with the V7 release on April 28th.

• Adding a user message directing users to the proper contact when an incident is in the Fire Reporting Status

Implementing the new NWCG Standards for Incident Name

• WFDSS will longer set Point of Origin Jurisdictional Agency Unit/Landowner Kind/Landowner Category. These will now be geospatially derived by IRWIN. WFDSS users will be able to change the Point of Origin Jurisdictional Agency Unit for records in which WFDSS has the Authoritative Data Source hierarchy to do so including to null the value. Changes in Lat/Long will trigger IRWIN to geospatially derive the value based on the changed values. • The default Incident size for records that come from IRWIN to WFDSS with no size will now be .01 (not .1) to align with the minimum size reduction from .1 to .01.

 - Fires Since 1/1/202 was rolled over into it's own layer in the historic perimeter bin.

• The NextGen development team is currently migrating NextGen to

it's permanent home along side IRWIN in the DOI hosting environment.

• Once the development environment is done being setup work will continue working on Incident search and browsing.
