### Classic WFDSS Updates:

- Testing next release has started for Oracle upgrade. Will take a while to complete.
- The timeframe for connecting to FamAuth (federal users accessing WFDSS with a PIV Card and Non-fed with Login.gov) is uncertain at this time. The Oracle Database upgrade is a priority and must be completed before we can shift the focus to FamAuth. When we are more certain when the work will start and released to the users, we will make sure the WFDSS users know, and specifically the GAEs.
- The Dev and Business team will be supporting S495 in class portion the week of April 17<sup>th</sup>.
- We are still investigating if we have the capacity to add in a static PODs layer this spring. Hope to have more info at the next GAE Meeting in April.

#### **IFTDSS Updates:**

- The development team has almost completed a major software upgrade for FTEM. The application will have a slightly different look this spring, but functionality will remain the same (with a few minor improvements).
- IFTDSS is next on the list for a major software upgrade this year that will ensure it remains "healthy" well in to the future. This work is expected to continue thru the remainder of the calendar year.
- The team is hoping to complete a few high priority enhancements along side the software upgrade, including incorporation of Landfire 2022 data and possibly adding new Landfire Look Up Rules for landscape editing to help users more easily create pre and post treatment landscapes for fire behavior modeling.
- The Tech Transfer team has been very busy this winter facilitating IFTDSS training in Burn Boss refreshers across the country as well teaching IFTDSS in fire behavior courses like S390.
- The second in person session of the National Fuels Academy was held in Florida in February and the team was in attendance to teach students how to use IFTDSS for NEPA planning.
- NAFRI hired several detailers to help with IFTDSS tech transfer this year. The selected candidates begin on March 27 and will be integral to meeting the increasing demand for IFTDSS training nationwide.
