### Reminders and General Awareness:

- Non-fed users are no longer required to show proof of security training to a federal GAE to gain access to the system. However, non-fed users with privileged accounts (Non-fed GAEs) will need to show proof of security training.
- WFDSS does not use INAP as a login method and therefore a INAP account is not required.

### RDA Staffing:

- Cheryl Bright has joined us for 120-days with the WFM RD&A. Cheryl will be working with the WFDSS NextGen team.
- Chris Moore has also joined us for 120-days and will be helping out the Fire Modeling Services Framework and WFDSS NextGen projects.
- We have 3 outreaches that have hit the road. The 9/11 Fire Application Specialist will be placed on the NextGen team. One of the 12/13 Fire Application Specialist position will be an IFTDSS team lead and the other will be the Tech Transfer lead. We anticipate the announcement is live in the next 4-6 weeks.
- The RDA is also outreaching for the 13/14 Deputy Program Manager. Multiple candidates may be selected from the outreach for consecutive assignments until the position is advertised for permanent fill.
- Data Analyst Fellowship through the ORISE Program application period was closed.

### **Classic WFDSS Updates:**

- 8.3 was released and the [8.3 release notes](#) are available and posted to the [What's New in WFDSS](#) page and Hot Picks section of the [WFDSS homepage](#).
- 8.3 release mostly included IRWIN v9 work, some FAMAuth cleanup, and adding PMS 236 Part D to the Organizational Assessment.
- Work continues on upgrading our Linux Operating system. We anticipate the switch over to Production and Training environments to begin possibly early next week.
- Arc upgrade was deployed in Production and Training environments.
- LandFire 2022 data was deployed in Production and Training environments. AK Zone 80 did not get loaded.
- 8.3.1 work has started and anticipate being released before upcoming fire season. This release is focused on upgrades and some prep work for archiving WFDSS data.

### **Geospatial Data Updates:**

- Data team attended the developers conference.
- WFDSS FMU/Strategic Objective Shape v82 were due to their agency leads for submission 3/7. The next scheduled data for v83 due to agency leads is 4/4.
- PODs will be updated in WFDSS Classic twice for the 2024 fire season. The first PODs editing deadline was due March 1, 2024. The next scheduled editing deadline is due June 1, 2024.

### **IRWIN Updates:**

### **NextGen WFDSS Updates:**

- FS Pro work nearing completion.
- Working to complete Landscape edits
- Strategic Assessment (objectives and requirements) is almost completed and plan to be in UAT shortly.
- We have the [UAT environment](#) up and running and set to where you can log in and take a look at what things are doing. Anyone is welcome to the application. When you put in a request, it will go to the WFM RD&A to approve.

### **IFTDSS Updates:**

- Currently wrapping up Arc Pro upgrade.
- Working to have the FTEM Dashboard available in the FTEM application.
- IFTDSS team presented the new 12 step framework for the wildfire crisis strategy landscapes at the Fuels Academy. FTEM and monitoring was also presented.
- Collaborative work with detailers from NAFRI continues. They attended and helped facilitate a workshop for IFTDSS on the Sawtooth NF. They are working on

instructor guides and other materials for workshops. For the next workshops the focus will be on Rx burn plans
