### RDA Staffing:

- The 9/11 Fire Application Specialist closed May 23<sup>rd</sup>. This position will be placed on the NextGen team.
- Wendy Detwiler will start her 120 detail for as IFTDSS team lead on 6/30.
- Tami Parkinson retired on May 31<sup>st</sup> after 33 years of service in forest and fire management.
- Reggie Goolsby accepted new position with Patent & Trade Office. A detail behind Reggie's previous position is in motion.
- Cherly Bright and Chris Moore wrapped up their detail with the RDA.

### Classic WFDSS Updates:

- Forecast feed for weather for analysis and other uses is working again. NWS is still working on setting up their new feed that they want folks to transfer to. They haven't given us a heads up on when they expect to have that ready or exactly what that feed looks like, but we are still trying to get information on that front. Because the Weather Service is in the midst of changing all of their infrastructure, we'd like folks to let us know as soon as they see any issues related to weather.
- 8.3.1.1 was released last week to address the issue with retrieval of fire weather zones stop working and were unavailable.
- 8.3.1.2 was also released that fixed an error where the resampling of LCPs with a resolution greater than 30 meters sometimes took longer than anticipated and

resulted in the LCP being corrupted. This was especially noted on large landscapes in Alaska.

- We are investigating delayed WFDSS Feedback notifications on Verizon cell phones via text messages from WFDSS.
- WFDSS continue to support this fire season and working on transitional planning with Nextgen. We have an 8.4 release that consist of this work and effort for preparing classic.

#### **Geospatial Data Updates:**

- FMU/Strategic objectives shape V84 data layer upload is being finalized and will be ready to be loaded in WFDSS Production and Training.
- The last scheduled WFDSS FMU/Strategic Objective Shape updates for the year is scheduled for the end of summer. After that we're locking the spatial fire planning data in Classic so that we can migrate it to the Spatial Fire Planning Service for Nextgen WFDSS.
- PODs Poly/Lines are available for users to view in WFDSS. This is the last snapshots of PODS to be uploaded into WFDSS for the year.
