

AGENCY ADMINISTRATOR PRIMER FOR WILDLAND FIRE TRAINING (BLM and USFS)

Updated February 2022

Note: Please refer to the current year Interagency Standards for Fire and Fire Aviation Operations (“Red Book”) for updated Agency Administrator core competency and training requirements for each agency (Forest Service – Chapter 5, BLM – Chapter 2).

Required – required for Agency Administrator (Forest Service – can vary by certification level and type, Wildfire or Prescribed Fire)

CE Option – Continuing Education (CE) option to fulfill the CE requirement for Forest Service AA certification levels for Journey, Advanced (Wildfire), Moderate and High (Prescribed Fire).

Strongly Suggested – Additional training which supports development of knowledge and skills

Good Opportunity – This course would improve the Agency Administrator’s knowledge of the fire environment
